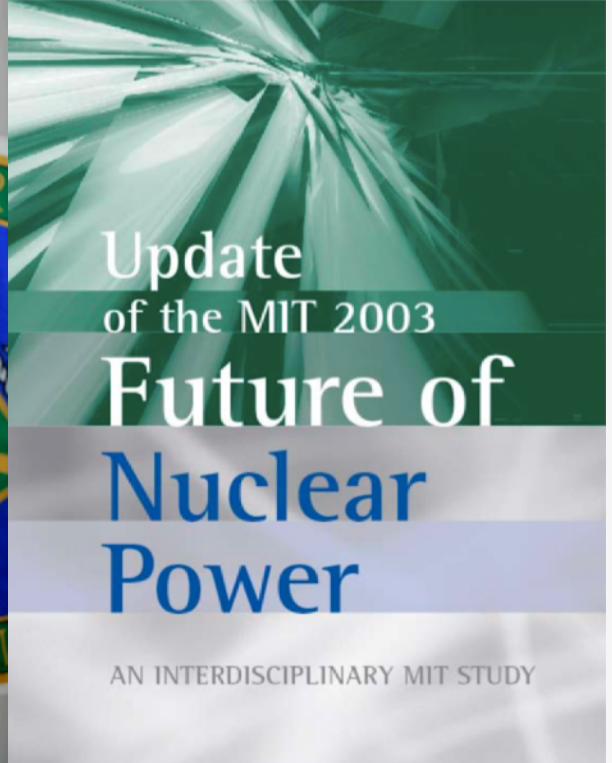
Since 2010, multiple [Iranian](#) nuclear scientists have been killed in foreign-linked [assassinations](#). Five were killed from 2010 to 2020 by [car bombings](#) or shootings.<sup>[1][2][3]</sup> [Fereydoon Abbasi](#) was among the scientists who survived an assassination attempt in 2010, an assassination that killed another nuclear scientist, [Majid Shahriari](#).<sup>[4][5]</sup> Abbasi was later killed on 13 June 2025 during [Israeli strikes on the Iranian nuclear program](#).<sup>[6][7]</sup>

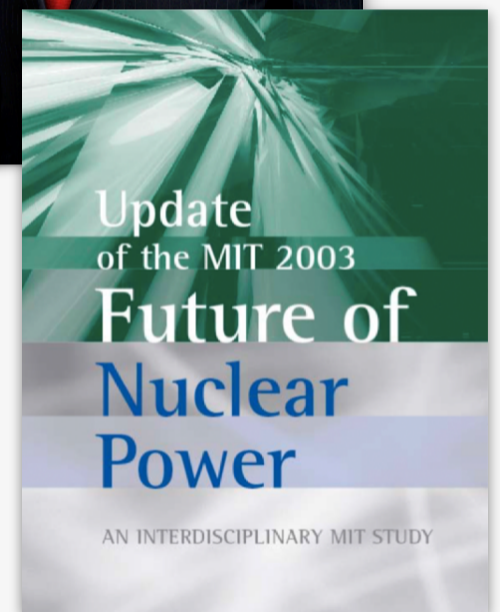
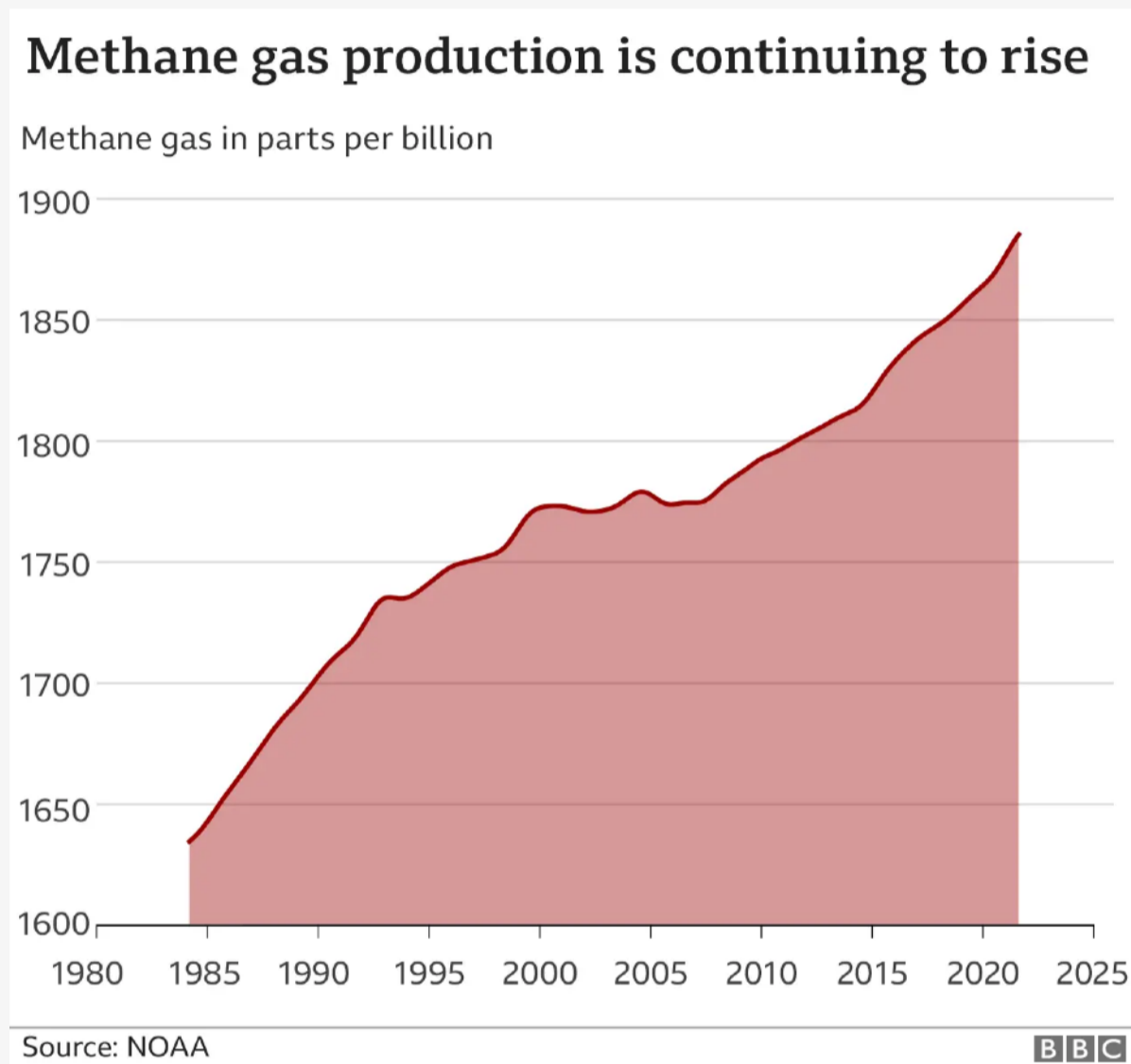

### INTRODUCTION

1. (U//FOUO) John M. Deutch held the position of Director of Central Intelligence (DCI) from May 10, 1995 until December 14, 1996. Several days after Deutch's official departure as DCI, classified material was discovered on Deutch's government-owned computer, located at his Bethesda, Maryland residence.

2. (U//FOUO) The computer had been designated for unclassified use only and was connected to a modem. This computer had been used to access [an Internet Service Provider (ISP)], the Internet, [Deutch's bank], and the Department of Defense (DoD). This report of investigation examines Deutch's improper handling of classified information during his tenure as DCI and how CIA addressed this matter.

3. (U//FOUO) Currently, Deutch is a professor at the Massachusetts Institute of Technology. He also has two, no-fee contracts with the CIA. The first is to provide consulting services to the current DCI and his senior managers; this contract went into effect on December 16,

JOINDER IN ACTION

COME NOW Jane Doe #3 and Jane Doe #4 (also referred to as "the new victims"), by and through undersigned counsel, to file this motion pursuant to Federal Rule of Civil Procedure 21 to join this action, on the condition that they not re-litigate any issues already litigated by Jane Doe #1 and Jane Doe #2 (also referred to as "the current victims"). The new victims have suffered the same violations of their rights under the Crime Victims' Rights Act (CVRA) as the current victims. Accordingly, they desire to join in this action to vindicate their rights as well. Because the new victims will not re-litigate any issues previously litigated by the current victims (and because they are represented by the same legal counsel as the current victims), the Government will not be prejudiced if the Court grants the motion. The Court may "at any time" add new parties to the action, Fed. R. Civ. P. 21. Accordingly, the Court should grant the motion.<sup>1</sup>
